DIRECTIONS FOR USE

Always test a small inconspicuous area before proceeding to ensure the finished result is satisfactory.

Preparation: Ensure surface to be treated is completely free from dust and dirt before application, if necessary, first wash area with Payetuf Deep Cleaner diluted 1:10 with water). Application: SHAKE WELL BEFORE USE, Do not dilute. Completely cover the rust stain with the product. Leave to act for 15 minutes. The product colour will change to a deep purple as It reacts with the rust, Once the indicated time has elapsed, scrub the area with a deck brush or nylon scrubbing pad and extract the residue using a sponge. Thoroughly rinse with plenty of water and leave to dry. Repeat application until the stain is completely removed.

KEEP UPRIGHT in a cool dry place. Shelf life up to 2 years if stored in the original unopened container at 5°C - 25°C (41°F - 77°F)
